What Is The Anti-Bias Task Force?



The East Hampton Anti-Bias Task Force is an official agency of the Town. Recognizing the destructive effects of prejudice and intolerance, the town of East Hampton created the Anti-Bias Task Force in 1993. It is

composed of concerned citizens appointed by the Town Board to work together to address instances of discrimination, prejudice, and intolerance.

Mission Statement

The Anti-Bias Task Force shall promote diversity, unity and understanding in East Hampton Town. It is our mission to promote education and raise community awareness of legal and legislative efforts to eliminate all forms of bias and prejudice.

RESPONSIBILITIES OF THE TASK FORCE

The Anti-Bias Task Force serves as a liaison between the community, religious institutions, law enforcement and government when an issue involving bias occurs or is perceived to occur. Its role is to:

- ◆ Serve as the community resource to which people can turn when they have complaints about bias-related incidents.
- ◆ Organize activities and forums to educate the community with respect to issues of bias and thereby foster good will and understanding in East Hampton Town.
- ◆ Advise and inform the Town Board concerning the appropriate responses to bias-related issues and incidents whenever necessary.

- ◆ Reach out to and advocate for victims of bias, receive complaints, and refer to appropriate agencies.
- ◆ Work with local schools, law enforcement officials, and elected representatives to promote a bias-free community.
- ◆ Develop a network of community representatives and foster responsible leadership in support of the goal of eliminating bias.
- ◆ Join with community leaders to promote equality of opportunity.
- ◆ Support legislative initiatives to discourage prejudicial conduct and protect victims.
- ◆ Bring people together in dialogue.
- ◆ Develop educational programs to foster an appreciation of diverse cultures and traditions, and to promote unity among people of the Town of East Hampton.
